

The Canadian Remedial Action Plan Implementation Committee (CRIC) is responsible for the overall coordination and implementation of actions that address the outstanding Beneficial Use Impairments (BUIs) applicable to the Canadian portion of the St. Clair River Area of Concern. The CRIC's responsibilities include work planning, developing clear ecosystem outcomes for each BUI (i.e., delisting criteria), ensuring monitoring

programs are in place to report on the status, trends and attainment of the indicators, and that reporting is completed in a timely, transparent and informative manner.



The CRIC consists of representatives from the federal, provincial and municipal governments, First Nations, industry and local community groups.
