3. SCRCA Education Program Update- Melissa Levi

- Both supported education programs were converted to a virtual format for the 2020-21 school year.
- Phosphorus 101 program is new and teaches about the activites occuring locally and their impacts downstream relating to phosphorus management. This program includes one day of in class learning, and one day of creative problem solving. This program targets grades 9-12.
- RiverRAP program delivered using he EnviroScapes tabletop activity and targets grades 7&8. This was delivered virtually as a livestream. High demand last year.
- In class programs set to return in February 2022 unless impacted by future covid restrictions.
- Melissa formally thanked the Friends of St. Clair River for their ongoing support.
- Friends expressed interest in supporting new program ideas as well as programs targeted towards college level students.
