3.0 Review of Action Items and Approval of November 1, 2022 Draft Minutes

4.0 Great Lakes Ecoregion Network Area of Concern Survey (GLEN) - Presentation - J. Jackson

- John spoke to a slide presentation on the outcome of a survey that was based on input from individuals from a number of AOCs, not just the St. Clair River.
- The survey targeted individuals active on committees the citizen activists. GLEN received responses from 30 individuals from 16 of the 43 AOCs.
- Main successes number one was public involvement. Others included restoration of fish and wildlife habitat, water quality improvements, and engaging Indigenous communities.
- One of the main challenges was addressing contaminated sediment, and other challenges included addressing increased phosphorus loadings, the need for clarity on binational delisting criteria/process, and what is going to happen after an AOC is delisted.
- In terms of threats to the AOCs, the main ones identified were: climate change; weakening of environmental regulations; reduction in resources to monitor, remediate and prevent; new toxic substances; and adverse impacts from new development.
- Need on-going public advisory and public action committees after delisting.
- Don't want to lose the gains that have been achieved to date.
- Protecting and preventing degradation of the environment is more cost effective than trying to remediate the damage that could potentially occur if it is not prevented.

- The presentation was not presented to the IJC but it was submitted to them. The IJC does take comments seriously. It was also sent to the Great Lakes Commission.
- Sheri explained that the FOSCR (USA) is planning for a joint St. Clair River AOC BPAC Symposium in 2025. The information in John's presentation on the new threats would be good content for a symposium.

5.0 Spill Notification Fact Sheet – Update on Progress – M. Moroney

- Mike explained that to support the work of the sub-committee that is to be formed to discuss creation of a Spill Notification Fact Sheet, as a first step, he created draft spill notification flow charts and met with Kris to discuss next steps. One flow chart was created based on the spill originating in Ontario and another for a spill originating in Michigan.
- Mike sought input from MECP's Sarnia District Office and St. Clair County Homeland Security, then reached out to Suncor.
- Suncor advised that they were also developing a spill notification flow chart and were seeking input from stakeholders, and once finalized would be able to share it with BPAC.
- As there is also the need for some clarity around the notification process on the Michigan side, input is being sought from the Michigan Department of Environment, Great Lakes and Energy.
- Further work on the flow charts is paused pending receipt of information from Suncor and Michigan.
- Once this additional information has been received, a sub-committee meeting will be scheduled
 to discuss the flow charts and further develop the FACT Sheet. Other topics that could
 potentially be included in the Fact Sheet are: spill notification legislation; and roles and
 responsibilities of the various parties identified in the flow charts.
- Kris suggested that the Fact Sheet have a flow chart designed in a way that is similar to a Story
 Map. A person can click on an image and get more details about that specific item. FOSCR (U.S.)
 has used that approach on their site.

- Paulette dotted line from SAC to St. Clair County should be included in the flow chart. Its not the official process but would be good to become the official process.
- It was recognized that the main purpose of the flow chart will be to just provide a high-level overview as opposed to an official process. Each agency/organization has their own internal procedures and processes.
- Reviewing and developing a flow chart may also help to identify gaps that need to be addressed.

6.0 Fish Consumption Advisories - Most Recent Canadian and American Data - P. Duhaime

- Paulette presented a number of slides related to Restrictions on Fish and Wildlife Consumption.
- Lots of data lately on the U.S. side on the analysis of fish that were sampled between 2016 and 2019.
- There are different criteria between the U.S. and Canada. On the U.S. side, the BUI will be considered restored when:
 - the fish consumption advisories in the St. Clair River AOC are the same or less restrictive than the associated Great Lake or appropriate control site, OR
 - if the fish consumption advisories in the St. Clair River AOC are more stringent than the associated Great Lake or control site, there are two possible approaches that can be used:
 - A comparison study of fish tissue contaminant levels can be conducted to demonstrate that there is no statistically significant difference in fish tissue concentrations of contaminants causing fish consumption advisories in the AOC compared to a control site.
 OR,
 - 2. Analysis of trend data (if available) for fish with consumption advisories shows similar trends to other appropriate Great Lakes trend sites.
- For the St. Clair River AOC, the control site is the Les Cheneaux Islands near the Mackinaw Bridge.
- Challenge is that can't get every species of fish at the control site that is in the SCR AOC, and difficult to catch the right species.
- For Canada, the BUI will be considered restored when fish consumption advisories in indicator fishes and wildlife in the St. Clair River are comparable to non-AOC sites in the Great Lakes. The indicator species are Walleye, Smallmouth Bass and Brown Bullhead. This analysis will be conducted after the sediment management plan has been implemented.
- Paulette outlined the current Michigan fish consumption advisories that are in place for the SCR AOC.
- Fish consumption guidance tends to be complicated. Would be helpful to communicate in way that can readily be used by those that fish.
- A targeted monitoring request has been submitted to Michigan EGLE and accepted. Want an
 additional round of sampling conducted in 2023. Requested that it be done for Walleye,
 Freshwater Drum, Rock Bass, Yellow Perch, Carp, Smallmouth Bass, Largemouth Bass and Lake
 Sturgeon.
- For Ontario, the fish consumption advisories are based on upper, middle and lower portions of the river. There is a difference between Ontario and Michigan in terms of how they determine what a safe consumption level is. Paulette spoke to the advisories in Ontario for walleye, smallmouth bass, and brown bullhead.

- Ted MECP did collect more recent data. They were able to collect 101 samples in 2021. This
 data will be used for the next round of Ontario's consumption guide. Also, there has been work
 on developing a framework that looks at 4 different tiers of fish consumption as another way to
 do the analysis for this BUI. It looks at the consumption advisories and remedial actions that
 could be completed to make a difference. Lastly, the final remaining project to address
 contaminated sediment is the implementation of the engineering and design plan to address the
 3 remaining priority areas.
- Ted A fish consumption survey was undertaken on the Canadian side and closed in December 2022. This will help understand what species of fish are being consumed. A report is being prepared on the outcome of the survey.
- Would be ideal if Canada and the U.S. can move this BUI forward at the same time.
- Melanie If MECP is able to have their subject matter expert come to speak to BPAC, Michigan EGLE may be able to have their subject matter experts participate as well.
- Paulette mentioned a webinar she watched about mercury and the use of isotopes to try to
 determine where the mercury is from. Did a study on the St. Louis River. Walleye had a higher
 level of mercury. Interesting findings from the study in terms of possible sources. May be helpful
 for this BUI. Action: There is a recording of the webinar and Paulette will share it with Patty
 Troy.

7.0 U.S./Canada Science Symposium - Proposal - P. Duhaime

- Thinking of a joint science symposium around 2025. Put in a PAC support grant.
- Terry commented on potential issue for individuals/presenters crossing the border and being paid for their participation.
- Action: Send suggestions of possible locations to Kris or Paulette and suggested topics.
- Donna the last event was at Double Tree in Port Huron.

8.0 Updating of BPAC By-Laws - P. Duhaime, K. Lee

- Kris and Paulette will work on updating the by-laws.
- Action: Send suggestions for amendments to the by-laws to either Paulette or Kris.
- Melanie all Michigan PACs have been asked to look at their by-laws. Looking at it from the
 lens of Diversity, Equity, Inclusion and Environmental Justice. A few Michigan AOCs have
 updates that Melanie can share. Action: Melanie to share a couple of examples of recently
 amended by-laws with Paulette and Kris.

9.0 Elections of Officers

- Paulette suggested that if the by-laws are going to be revisited, might want to consider changing
 the frequency of elections of officers to once every 2 years, instead of the current once every
 vear.

11.0 Agency Updates

Ministry of the Environment Conservation and Parks - Ted Briggs

 MECP now putting out funding to various groups based on submissions they made to MECP in 2022. FOSCR is one of the organizations that will be receiving funds.

Environment and Climate Change Canada- April White

- Continuing to provide support for RAP Coordination. Extended the agreement into the third year with SCRCA. ECCC is also renewing agreements with local FN communities.
- ECCC will be having an internal reorganization. Related to creation of a new Water Agency. Expecting an announcement shortly. Will change reporting structure.

Michigan Department of Environment, Great Lakes, and Energy (EGLE) - Melanie Foose

- Sept 12 to 14 is next AOC conference in Green Bay, Wisconsin.
- Looking at fish consumption sampling this year.
- Andrew Bahrou is the new Lake Coordinator for Lake Erie which includes Lake St. Clair and the St. Clair River.
- Two BUIs left on the U.S. side, Fish Consumption and Drinking Water. Waiting for facility response plans from DTE. One of two plans completed.
- Rick Hobrla is retiring on March 31, 2023 to fill the upcoming vacancy. Melanie was the successful candidate Unit Supervisor, Great Lakes Management Unit. There will therefore soon be a new AOC Coordinator for the SCR.

U.S. Environmental Protection Agency – Michael Hennessy

- Michael provided some staff updates within U.S. EPA.
- Michael is the lead for US EPA in developing the agenda for the upcoming conference on September 12th to the 14th that Melanie referenced.

i. Statewide Public Advisory Council (SPAC) - Patty Troy

- There are two vacancies that need to be filled in Michigan EGLE for the AOC program.
- SPAC is planning another all AOC webinar. They are looking for topics for the webinar and sent out a survey. **Action:** Patty to send the survey link to Mike for distribution to BPAC members. Looking for dates in April 2023.
- The possibility for a state-wide AOC outreach tool was discussed at the last SPAC meeting, ideas included a video to highlight statewide success and the general AOC program or a story map.

- Undertaking a project to update 5 signs along the St. Clair River for public education. Hope to have them in place this summer.
- Funding from MECP for FOSCR (Canada) is now coming indirectly through another group.

iii. Friends of the St. Clair River (USA) - Sheri Faust/P Duhaime

- Sheri provided information on a crowd source photo monitoring project. Photo stations
 are located along the river. Phones are placed in the bracket and a picture is taken then
 uploaded to their website. The photos contribute to a time lapse image of that area along
 the river. It helps monitor water levels, erosion, vegetation etc.. Interested in seeing
 outcome after 3 years. They are currently in to year 2.
- Have a date for the Sturgeon Festival Saturday June 3, 2023 at the lighthouse in Port Huron.
- Ted confirmed that if FOSCR decide to use their funds for the photo project, it would be in line with what the funding is being provided for public outreach.

iv. Canadian RAP Implementation Committee (CRIC) - Kris Lee
