Meeting called to order shortly after 10:00 am

1. Welcome and Introductions:

Ted Briggs chaired the meeting and welcomed CRIC members to the November 7, 2023 virtual meeting.

2. Approval of Agenda

The November 7, 2023 draft agenda was approved.

3. Acceptance of Minutes from May 11, 2023 Meeting

The minutes from the May 11, 2023 meeting were approved.

4. Review of Action Items from May 11, 2023 Meeting

- a) April White to share an updated draft Assessment Report for BUI 3 Degradation of Fish and Wildlife Populations to CRIC members **Completed.**
- Naomi to submit a request to Chief and Council for time on the agenda on January 24, 2023 for a presentation on BUI 9. – Completed on July 18, 2023
- c) Mike to discuss with Donna on what approach has been used in the past to make the community aware of an opportunity to review and provide comments on a draft BUI status assessment report. – Completed.

5. Status of Beneficial Use Impairments – April White, Ted Briggs

BUI 1- Restrictions on Fish and Wildlife Consumption (Impaired): Ted explained that the fish consumption survey was conducted in 2021 and 2022 in support of this BUI and reminded members that making progress on both BUI 1 and BUI 6 is tied to the contaminated sediment work. Dow Canada will be leading the implementation phase of the sediment work and they require one more permit to be in place before they can proceed - from MNRF. The consultant was hoping to mobilize to the site this week but that might be delayed due to the need to have this final permit in place. The in-water work is expected to take two weeks to complete. Ted will update the committee when there is new information to share.

BUI 6 - Degradation of Benthos (Impaired): As explained in BUI 1, the ability to redesignate this BUI is also linked to work on the contaminated sediment in the three priority areas of the St. Clair River.

BUI 3 - *Degradation of Fish and Wildlife Populations* (RFA): The draft status assessment report has been completed for this BUI and the report findings will be presented by April today under agenda item #6.

BUI 9- Restrictions on Drinking Water Consumption, or Taste and Odour Problems

(Impaired): Ted explained that since the last CRIC meeting, presentations to redesignate this BUI have been made to Walpole Island First Nation Chief and Council, BPAC and the Four Agency Managers Committee. Walpole Island First Nation acknowledged receipt of the information presented and BPAC confirmed its support with the recommendation. Michigan Environment, Great Lakes and Energy did not have any comments on the recommendation. The US EPA is still reviewing the recommendation and their comments, if any, are expected to be received soon. Once all comments have been received and considered, the recommendation to redesignate this BUI to not impaired will go to the COA Co-Chairs from MECP and ECCC for approval. (Note: The report was also posted to the FOSCR website for review and public comment until December 11, 2023)

BUI 14: *Degradation of Fish and Wildlife Habitat* (Impaired): April advised that a draft status assessment report has been prepared and is with DFO for input. DFO currently has some capacity challenges which is impacting their ability to provide input on the report and the Aquatic Habitat Management Plan. The goal is to have a final draft before the end of December 2023 and to be able to present the report and the recommendation to CRIC in Spring 2024.

6. BUI #3 Status Recommendation Report and Fact Sheet – Degradation of Fish and Wildlife Populations

- April spoke to a PowerPoint presentation summarizing the findings of the status recommendation report, recommending that this BUI be redesignated from "requires further assessment" to "not impaired".
- The initial draft report was presented in June 2021. Revisions were made to improve the readability and the quality of the report.
- The report is about 300+ pages in length, which includes the appendices, and forms a strong foundation to support the recommendation that this BUI be redesignated to not impaired.
- Kim did some of the revisions and authored a lot of the reports related to this BUI and also prepared the Fact Sheet summarizing the highlights of the report.
- The presentation outlined the delisting criteria that needed to be met and key findings of the various studies that were completed to support that the criteria has been met.
- There were two components to the assessment; abundance and diversity of wildlife and, secondly, the accumulation of contaminants that may impair the ability of fish and wildlife populations to be self-sustaining.
- The assessment also included incorporating Indigenous ecological knowledge, provided by Walpole Island First Nation.
- With respect to the assessment of the first component, information was provided on: waterfowl abundance between 2009 and 2011; waterfowl trends within the AOC compared to outside the AOC; abundance and diversity temporal trends; spatial trends for marsh birds; and a comparison of marsh birds, amphibians, and mammals within the AOC to areas outside the AOC.
- With respect to the assessment of the second component, information was provided on the outcome of the assessment of Shorthead Redhorse Suckers for heavy metals, mercury burdens, temporal trends for PCBs and Organochlorines, and body measurements. Contaminant burdens for wildlife was assessed using Northern Leopard Frogs, Snapping Turtles, over-wintering waterfowl (Canvasbacks), and Mink.
- The presentation concluded with April explaining that the assessment of the data confirms that the conditions for wildlife diversity and abundance have been met, and contaminant body burdens are not impairing the ability of fish and wildlife populations to be self-sustaining in the AOC. The recommendation is to therefore to redesignate this BUI from "requires further assessment" to "not impaired".

7. Funding Updates

7.1. Environment and Climate Change Canada - April White

- GLPI call for proposals for 2024/2025 funding could be in November 2023 or late December 2023.
- The First Nation Indigenous agreements are already in place until 2025.
- Waiting to see what funds will be made available for the Great Lakes AOC program.

7.2. Ministry of the Environment Conservation and Parks - Ted Briggs

- The funding that is in place for the St. Clair River RAP Coordinator will be ending in a few months. Waiting for confirmation of approval for funding for 2024/2025. Once confirmed, Ted will start working on preparing the funding agreement for SCRCA.
- MECP put out a call for proposals under the Wetlands Conservation Partner Program
 to restore and protect wetlands across the province. The deadline for submissions
 was October 12, 2023. Proposals received are currently under review.

7.3. Ministry of Natural Resources and Forestry- Stephen Marklevitz

 MNRF was able to get the Connecting Channels AOC fish community assessment program in place and will be doing the Detroit River this year. The St. Clair River will be next year. Would like to focus on previous restoration sites if possible.
